  - 1.3. All ideas and content drawn from sources other than the author(s)' original work has been cited accordingly and at no point does the article infringe upon any extant copyright.
2. My submission to Spontaneous Generations has not been published or submitted for review and shall not be submitted for review elsewhere.
  - 2.1. Any future re-publication of any version of this article or any portion of this article in any publication other than Spontaneous Generations shall be permitted by a sitting editorial board of Spontaneous Generations prior to submission for publication.
